Chair's Report

Welcome to the 2009/10 Annual Report which will give you a good overview of NADS ongoing campaigning, works and disability awareness projects on behalf of all disabled supporters. As I reach the end of my first term as NADS Chair it seems appropriate to reflect on the last 3 years and the many tremendous successes of the NADS Board of Trustees, Administrator, co-optees, volunteers and members.

It's fair to say that NADS has been through a period of considerable change over the last three years; to be honest we'd somewhat lost our way and were out of touch with members, disabled supporters and key partners. We needed to re-establish some crucial relationships, gain influence and respect across football and the political arenas and reengage with those we represent. I'm proud of the work of the Board of Trustees on all these fronts and our ever growing membership proves that we are back on track and can build on the good works of the NADS founders.

We now have a firmly respected position within football and have gained a respected political voice with the All Party Parliamentary Football Group endorsing our recommendations in their Report on English Football and its Governance. NADS has met with the Equality and Human Rights Commission (EHRC), the Minister for Sports and Secretary of State and a number of key Lords and Baronesses and Members of Parliament to discuss the continuing issues and challenges faced by disabled supporters.

NADS leads on a number of disability awareness initiatives including the Wigan based Never Watch Alone Initiative (NWA), a buddying scheme for learning disabled supporters, as well as the NADS Level Playing Field weeks of action each season. We also work closely with a number of likeminded disability charities and organisations including Kick it Out, Mencap and Changing Places, Guide Dogs for the Blind, Action for the Blind, RNIB, the National Deaf Children's Society, DisabledGo, Whizz Kidz, Embrace, Stadium Communities and others. Thank you to all, for your ongoing support.

Alongside this we have enhanced our reputation within the game by recruiting highly respected Honorary Officers along the way including NADS President, David Bernstein (Chairman of Wembley), Sir Trevor Brooking, Lord Richard Rosser of Ickenham and ex-players Danny Wallace and Danny Mills. Danny Mills has joined up with Danny Wallace this year as our second ex-professional player – you can never have enough Dannys ☺! Both are brilliant role models who take every opportunity to raise awareness for disabled fans with Danny ‘M’ raising much needed funds for NADS with his Brighton wheelchair marathon earlier this year.

David Bernstein and his fellow Honorary Officers (you’ll find a full list at the end of this report) are tremendous ambassadors and advocates for disabled supporters. They are always more than willing to dedicate their precious time, energies and expertise to our cause and I warmly thank each and every one of them on behalf of the NADS members for their unwavering support and friendship. Quite simply we couldn’t do it without them.

It is through the successes of NADS in the UK that we have gained European recognition advising UEFA on disabled supporter provisions for EURO 2008 and the UEFA and Champions League Finals in 2008 and 2009. In 2008, we won the European Football Supporters Award and in August 2009, UEFA dedicated their Monaco charity award of 1 million Swiss Francs to establish a new charity to continue NADS works across UEFAs 53 member associations. The Centre for Access to Football in Europe – CAFE is now up and running. I’m proud to be taking a lead on this work as its Managing Director with the support of David Bernstein as Chairman along with several of the NADS Vice Presidents and Danny ‘M’ and ‘W’. CAFE has made a good start alongside the European Football Family to further our ambitions across Europe and beyond. We’ve come a long way.....

It’s been another extremely busy year for the NADS team and perhaps one of the biggest successes we’ve seen has been the increasing numbers of disabled fans prepared to challenge the current unequal situation at some clubs to the benefit of all of us. This is something that is to be applauded, as it is only through constructive complaints, positive feedback and the sharing of good practice that we can effect lasting and meaningful change. To this end, NADS has produced a ‘How to Complain’ help sheet which is available on the website or on request. We can all sense the change that is afoot and that is a good thing that we should each be proud of – disabled fans, club staff, the football authorities, the EHRC and government. However there is still much to do and we mustn’t become complacent as we each play our part in ensuring an inclusive and equal future for all fans.

Probably our best kept secret is that NADS operates on an absolute shoestring, with football providing funding of only £20k last year and less still so far secured for this coming year. We have one part-time member of staff and everything else is down to volunteers and the generosity of a number of companies, organisations and individuals who provide in-kind support and donations. There are so many of you now doing your level best to support us - to each and every one of you a very huge thank you.

When compared with our peers inside football and across the disability sector, it's just amazing how much we've managed to achieve and on how little. We punch well above our weight. To be honest, it's unfair on everyone involved and things have got to change on this front, and soon.

It is vital that disabled people are empowered and able to lead on improving equal access and disability rights. NADS is a great example of an effective user-led organisation affecting change. We must be able to continue and it's time to show us the respect we deserve, to acknowledge our important works and unwavering support to the football family, key stakeholders and our members.

Again, we call on the Football Authorities to provide NADS with realistic and secure funding. We are all exhausted with some of us having to volunteer unsustainably long hours to keep NADS afloat but we all remain resolute and absolutely determined to deliver equality – a Level Playing Field - for the many thousands of dedicated disabled fans that remain so loyal to our beautiful game.

In closing, I also wish to thank the many individuals (you know who you are) who work extremely hard on our behalf and often behind the scenes. Your ongoing commitment, friendship and support are hugely appreciated by us all.

I wish you all a great summer and should you chose to re-elect me as your Chair for the next 3 years, I will be honoured to continue working with you all next season.

About NADS

The National Association of Disabled Supporters (NADS) was established in 1998 and is the only national registered charity representing all disabled supporters – football and other sports. Our objective is to promote an inclusive agenda, raise disability awareness and enhance health and well-being through football, and to ensure an equality of spectator experience for all fans.

NADS represents the views, issues and concerns of disabled football supporters to football and governmental authorities and provides independent advice on disability issues as they affect the football community. NADS also heads up the disabled branch of englandfans.

NADS is an umbrella organization recognised as the representative and co-ordinating body of all disabled football supporters and their carers/advocates. 45 Football Clubs have joined NADS and it is our aim that all 92 professional clubs should become members. We have 48 Disabled Supporter Association (DSAs) members (16 full and 32 associated members) and 6 affiliated group members representing more than 22,000 disabled supporters. Individual associate membership is also growing rapidly, currently sitting at 4,600. We estimate that 30,000 disabled fans regularly attend football matches in England. The success of the NADS disabled branch of englandfans shows that this passion naturally extends to the national team with Wembley National Stadium standing as a beacon of good practice.

If you mention the word disabled, most people will first think of someone in a wheelchair. However disability is diverse and to ensure that we are truly representative and inclusive, NADS has a management Board of Trustees and volunteers that all reflect the diversity of disabled people. All are football fans supporting teams across the leagues and national sides. This is important in understanding the issues and challenges that disabled supporters face and gives us a unique understanding of the fans that we represent.

It is considered good practice across the service industry, including local council and sports governing and representative bodies such as London 2012, that there should be a user-led consultation or representative group such as NADS for diversity and equality strands. It is a good practice that is well proven and NADS has a significant membership that reflects our pan-disability expertise and detailed understanding of equality and good access.

Most stakeholders understand that where complex discrimination (such as unequal access and disability abuse) still exists then it is imperative that a user-led representative body or organisation is in place to ensure ongoing and meaningful consultation and direction. The newly formed EHRC recognised this significance by deciding to maintain a disability directorate within the new Commission structure. It is also important to empower minority groups such as disabled fans and there is no better way than through an organisation such as NADS which is led by disabled fans for disabled fans. It is recognised as absolute good practice that disabled people should represent themselves as empowered user-led groups.

There are around **12.4 million disabled people in the UK with a spending power of £91 billion per annum**. It is estimated that at least 30,000 are currently active disabled fans regularly attending a professional football match and it is unknown how many more follow the game from home as 'arm chair' fans.

We firmly believe that there is a significant opportunity for clubs to recruit new customers or fans from among the disabled community along with their families and friends. Providing an inclusive stadium with equal facilities which enable disabled fans to sit together with their own fans, families and friends makes good business sense. NADS has many examples of achievable good design solutions for existing and new stadia and is working with the football and sporting family to promote further supporter/spectator inclusion.

Aims of NADS:

- **To be a voice for all disabled supporters and spectators**
- **To campaign for equality of supporter experience**
- **To enrich the lives of disabled people through football and other sports**
- **To raise disability awareness**



Key achievements for 2009/10

- NADS was invited to meet with the Equality and Human Rights Commission and gave a detailed overview of the **State of the Game**. As a result, the EHRC and the football authorities are continuing to work together in co-operation with NADS to improve access and equality for disabled football fans.
- This season's NADS **Level Playing Field (LPF)** weeks of action were a great success with clubs and disabled supporters associations up and down the country raising disability awareness. This year's campaign focused on Ambulant Disabled Supporters.
- Early 2010 saw the continuation of **regional Fans Forums** with NADS going "on the road" in the South West to hear disabled supporters views and let you know what we have been up to.
- NADS, the Federation of Stadium Communities and the Wolverhampton Deans School are jointly running a **pilot study – Football for All**. This project, funded with an Awards 4 All Big Lottery Grant, looks at how to encourage newly disabled people to attend sports matches. We are aware of the many benefits of being part of the match day experience which can often be life-changing for a disabled person, breaking down barriers, raising self-esteem and promoting inclusion and well-being. Football has a powerful voice and can reach out to people like nothing else.
- NADS acted as a consultant to the recent **Football League Disabled Fans Mystery Shopper** project and supported the resultant 4 regional Customer Services Seminars presenting the key issues and challenges for disabled supporters.
- **UEFA** awarded their **Monaco Award for 2009** to enable the set up of the Centre for Access to Football in Europe – CAFE. This new organisation, which is outward facing to Europe and independent of NADS, is building on the work undertaken by NADS in the UK.
- NADS has exceeded previous years with a further **increase in membership for 2009/10**. We are extremely proud of this achievement, which gives us the mandate and expertise to directly represent more than 22,000 pan-disabled supporters.
- The Wigan '**Never Watch Alone**' Initiative went from strength to strength with the local charity Embrace taking over the day to day management. This is a buddying project that brings together fans with learning difficulties and non-disabled fans on match days and encourages lasting friendships beyond match days and working alongside other fans groups.

- We continue to represent disabled spectators of all sports and sit on the **London 2012 Olympic Delivery Authority Built Environment Access Panel**. NADS has recently been appointed as the primary user-led advisors to the **London Organising Committee for the Olympic Games, LOCOG, London 2012**. We also continue to give user advice to cricket and rugby.
- NADS sits on the Inclusivity Advisory Group for the **England 2018 bid**. NADS sees a successful Bid as a tremendous opportunity for disabled supporters and improved access to football in this country. As such, NADS and its members have passionately supported and promoted the Bid.
- NADS continues to hold an important user-led consultative role in the **design and build of new stadia and stadia improvements** with experience showing that this involvement has a real benefit. This requires a great deal of resource and probably accounts for the biggest share of our ongoing works. In the last 12 months NADS has been advising on new stadia, stadia developments, improvements and advice at more than 39 clubs and football venues. We currently receive no reimbursements for this area of work and have to meet our own resource and travel costs.
- NADS has implemented an **Access Audit programme** for clubs who wish to commission access audits. We have secured special rates with a team of consultants who specialise in sports stadia access with reference to the Accessible Stadia Guide, the DDA and good access in general. Each consultant is listed with the National Register of Access Auditors (NRA) as an accredited Access Auditor and Access Consultant. To find out more please contact NADS at stadia@nads.org.uk



Treasurer's Report



Results for the Year

It has been another trying year for NADS financially. We continue to operate without major or secure core and project funding and spend a considerable amount of our time on trying to raise finance.

However, despite this and thanks to the hard work and dedication of the NADS Board of Trustees, the Administrator and volunteers, we have continued to support the football authorities and to provide user-led advice to football, cricket and London 2012 as well as to disabled supporters generally.

You will find a roll call at the end of this report. Please do accept our apologies if your name does not appear, there are so many of you now doing your level best to support us - to each and every one of you a very huge thank you.

Fundraising activities

The Football Association provided us with £10,000 funding donations for June 2009-June 2010 and met our expenses for an electronic note taker to ensure that our meetings were fully accessible. Alongside this we continue to receive part funding for the Administrator post from the Football Stadia Improvement Fund.

We also secured a Big Lottery Funding – Awards 4 All - Grant of £10,000 towards our Football for All pilot project.

Ambassador, Danny Mills has chosen NADS as one of his special charities raising much needed funds for us by taking part in the Brighton Marathon using a wheelchair to further raise awareness. Funds are still coming in as we go to press but Danny has told us that he expects to raise around £5000 for NADS which is tremendous. Thank you Danny.

As well as these kind and very welcome donations and awards we have received various donations from organizations and individuals that have enabled us to carry on with our important works and campaigns throughout the year.

Our limited resources are considerably over stretched and it is crucial that a secure funding source be identified to ensure that NADS can continue to lend its considerable support its members and the football family and to continue campaigning for equal access for all fans.

I would like to say a very special thank you to everyone who has helped us to raise money in the last 12 months. Your generous support is vital to all we do and I am proud to include the NADS Roll of Honour 2009/10 listing our kind benefactors at the end of my report.
